Forty-second Legislative Day, Wednesday, April 14, 2010

In order to encourage production of firearms within the state of Oklahoma, the Oklahoma Department of Commerce shall collaborate with an Oklahoma institution of higher education that offers a gunsmith curriculum to develop strategies to attract firearms manufacturers to locate within the state of Oklahoma.

B. Such institution of higher education shall designate a liaison with the Oklahoma Department of Commerce to coordinate said efforts.

C. It is the finding of the Oklahoma Legislature that the manufacturing of firearms is a manufacturing activity classified in the North American Industry Classification System (NAICS) Manual under Industry Sector Number 33, as defined in Section 3603 et seq. of Title 68 of the Oklahoma Statutes, and therefore qualifies for certain economic incentives.

D. As a means to better protect Oklahomans’ right under the Second Amendment to the U.S. Constitution to keep and bear arms, it is the intent of the Oklahoma Legislature that the Oklahoma Department of Commerce, and other agencies of this state charged with the responsibility of recruiting or assisting in the recruitment of businesses, actively promote the use of existing economic incentives as inducement for firearms manufacturers to relocate within Oklahoma.”, and by renumbering subsequent section and amending the title to conform, which amendment was declared adopted.

Senator Brogdon moved that **HB 2994** be advanced, which motion was declared adopted.
