“SECTION 7. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 7100 of Title 36, unless there is created a duplication in numbering, reads as follows:

A. For purposes of this section:

1. “Health care provider” means any person or entity who is licensed, certified, or otherwise authorized by the law of this state to administer or offer health care in the ordinary course of business or practice of a profession; and

2. “Medical services” means any care, service or treatment of illness or dysfunction of, or injury to, the human body including, but not limited to, physician care, inpatient care, hospital surgical services, emergency services, ambulance services, dental care services, vision care services, mental health services, substance abuse services, chiropractic services, podiatric care services, laboratory services, and medical equipment and supplies.

B. The Oklahoma Health Care Authority shall establish and maintain a program by which the Authority will serve as administrator and collector for all charges for medical services for uninsured persons in the state with household incomes at or below one hundred thirty three percent (133%) of the federal poverty level.

C. Health care providers shall file all charges for medical services for uninsured persons with household incomes at or below one hundred thirty three percent (133%) of the federal poverty level through the Authority.

D. The Authority shall collect such charges from uninsured persons with household incomes at or below one hundred thirty three percent (133%) of the federal poverty level and submit such payment to the health care provider.

F. Nothing in this section shall be construed to mean that the Authority is responsible for reimbursement of any unpaid charges for medical services.

G. The Oklahoma Health Care Authority Board may promulgate rules as necessary to implement the provisions of this section, including, but not limited to, rules authorizing the Authority to collect a fee to cover the administrative costs associated with implementing the provisions of this section.” and by amending the title to conform.

This is to advise you that on this date, pursuant to the authority vested in me by Section 11 of Article VI of the Oklahoma Constitution to approve or object to legislation presented to me, I have VETOED Senate Bill 186. This bill would extend the date for the termination of the Polygraph Examiners Board, the State Board of Osteopathic Examiners, the Board of Podiatric Medical Examiners, and the Oklahoma State Athletic Commission from 2011 to 2014. Senate Bill 186 conflicts with House Bills 1015, 1016, 1017, 1018, and 1019, which extended the date from 2011 to 2015. These House Bills were signed into law on April 13, 2011.
