Forty-fourth Legislative Day, Wednesday, April 27, 2011

“D. Money from the Oklahoma Quick Action Closing Fund, nor any other public funds, shall not be transferred to, expended at the request of, or expended on behalf of any:

1. Corporate entity, or affiliated corporate entity or partnership; or
2. Partnership, or affiliated corporate entity or partnership;

if such entity or partnership makes independent expenditures, payments, or in-kind contributions, directly to or indirectly through entities which one would reasonably believe will be used for electioneering communications on behalf of or against any one or more political parties or candidates for state office. This prohibition shall apply for the twelve-month period preceding and for the five-year period following the later of the application for or distribution of expenditures from the Oklahoma Quick Action Closing Fund or other public funds.

Every applicant or direct beneficiary, as a prerequisite to the expenditure of any money from the Oklahoma Quick Action Closing Fund or other public funds, shall agree not to make such contributions, independent expenditures or payments.

The president of the board, chief executive officer of the corporate entity or general or managing members of the partnership, shall provide a notarized affidavit evidencing compliance with the provisions of this section upon expenditure of such funds and each year thereafter for the five-year period. If no such affidavit is filed or if a corporate entity

or partnership otherwise violates the provisions of this subsection, any money from the Oklahoma Quick Action Closing Fund or any other public funds shall be repaid to the State Treasury, for deposit to the fund from which expended, with interest at the rate assessed by law upon delinquent income taxes.”, and by re-lettering subsequent subsections, which amendment was declared adopted.

Senator Mazzei moved that **HB 1953** be advanced, which motion was declared adopted.

Supp. 2010, Sections 4602 and 4603), which relate to the Health Care for Oklahomans Act; eliminating the Health Care for the Uninsured Board; authorizing the establishment and operation of the Health Insurance Private Enterprise Network; defining terms; establishing the Network as a state-beneficiary public trust; providing for a Board of Directors; specifying membership; requiring the Insurance Commissioner to serve as chair; requiring the appointment of an Executive Director; specifying funding sources for the Network; specifying purposes of the Network; prohibiting the Network from taking certain actions; modifying duties of the Network Board; requiring certain information to remain confidential; authorizing the Board to promulgate rules; clarifying purpose of certain program; requiring legislative review and renewal; and providing an effective date.
