word “cheetahs, by deleting all language and inserting “non-native”; Page 5, Line 22, after the word “other” and before the word “species”, by inserting “non-native”; Page 5, Line 23, after the word “servals,” and before the word “Canadian”, by deleting all language; Page 14, Line 18, after the word “leopards,” and before the words “snow leopards”, by inserting “and”; Page 14, Line 18, after the words “snow leopards” and before the colon, by deleting all language; Page 15, Line 4, after the word “including” and before the word “lynx”, by deleting all language; Page 22, Line 20, after the word “Agriculture” and before the word “educational”, by deleting all language and inserting a comma; and Page 22, Line 20, after the word “facilities” and before the word “shall”, by inserting “and persons who keep or maintain native cats that will grow to reach the weight of fifty (50) pounds or more subject to regulation by the Oklahoma Department of Wildlife Conservation.” and renumbering subsequent sections, which amendment was declared adopted.
