Advising passage of and transmitting for consideration Engrossed **HBs 2270, 2476, 2621, 2676, 2777, 2970, 2978, 3056** and **3061** and **HJR 1089**.

HB 2270 – By Cox, Jackson, Hilliard, McNeil, Ownbey, Williams, Sherrer and Hoskin of the House and Johnson (Rob) and Burrage of the Senate.

An Act relating to poor persons; amending 56 O.S. 2011, Section 2002, which relates to the Nursing Facilities Quality of Care Fee; providing fee shall not exceed certain amount if federal waiver is approved; providing for determination of fee; providing for certain assessment rate for certain facilities if federal waiver is approved; providing for certain assessment rate for certain facilities if licensed by certain date; providing for certain assessment rate for certain facilities that fail to receive license by certain date; and providing an effective date.

HB 2476 – By Scott and Sherrer of the House and Johnson (Rob) of the Senate.

An Act relating to cities and towns; amending 11 O.S. 2011, Section 22-111, which relates to general powers of municipalities; modifying notice requirement; modifying number of days to send certain statement to treasurer; and providing an effective date.

HB 2621 – By Johnson of the House and Mazzei of the Senate.

(revenue and taxation - amending 6 Sections in Title 68 - tax credits – noncodification - emergency)

HB 2676 – By Shumate of the House and Eason McIntyre of the Senate.

An Act relating to schools; establishing the Oklahoma Bridge to Literacy Program; stating purpose of the Program; directing the State Department of Education to issue requests for proposals by certain dates and to review applications; describing private entities eligible to submit applications; providing for approval of applications; specifying requirements of approved application reading programs; requiring the Department to forward approved applications to the State Board of Education; directing the Board to award grants through a competitive bid process; requiring awards to be made statewide; stating uses of grants; directing the Department to provide certain training, resources, and assistance to grant recipients; directing the Board to provide for independent evaluations of the funded programs; requiring the Board to prepare and submit a report; specifying contents of the reports; providing for codification; providing an effective date; and declaring an emergency.

HB 2970 – By Thomsen, Sherrer and McDaniel (Jeannie) of the House and Brecheen of the Senate.

An Act relating schools; amending 70 O.S. 2011, Section 1210.523, which relates to the Achieving Classroom Excellence Act of 2005; requiring the State Board of Education to adopt certain rules; providing for an appeals process for certain students; providing time limits for appeal and Board action; requiring the Board to collect certain data; requiring annual report; and declaring an emergency.

HB 2978 – By Dank and Pittman of the House and Mazzei of the Senate.

(revenue and taxation - allowing identification of certain persons - requiring creation or retention of jobs – tax credit - termination date - prior approval of certain activity - requiring audits by the State Auditor and Inspector - fiscal impact – effective date - emergency)

HB 3056 – By Steele and McDaniel (Jeannie) of the House and Bingman of the Senate.

(state government - amending 70 O.S., Sections 26-103 and 26-104 – flexible benefit allowances - amending 7 sections in Title 74 - State and Education Employees Group Insurance Act - Oklahoma State Employees Benefits Act - effective date)

HB 3061 – By Steele of the House and Bingman of the Senate.

(revenue and taxation - Oklahoma Tax Reduction and Simplification Act - Oklahoma Income Tax Code - modifying taxable years for which certain tax rates applicable - tax

based upon taxable income amounts - reduction of individual income tax rates based upon certain revenue conditions - State Board of Equalization - elimination of certain individual income tax credits - Oklahoma Income Tax Code with respect to certain deductions and exemptions – repealing sections -effective date)
