Second Regular Session of the Fifty-third Legislature of the State of Oklahoma

Fifty-third Legislative Day, Thursday, May 10, 2012

The Senate was called to order by Senator Stanislawski.

FIRST READING

A Concurrent Resolution relating to legislative procedures; establishing a legislative procedure schedule for the 54th Oklahoma Legislature.

SR 58 – By Schulz.

A Resolution relating to the protection of the property and supplies of the Senate and duties of the President Pro Tempore during the 2012 legislative interim; authorizing employment of necessary personnel; restricting use of Senate offices and Senate Chamber during the interim except with the consent of the President Pro Tempore; authorizing repairs to the Senate Chamber, Senate offices and furnishings and purchase of needed furnishings and equipment therefor; authorizing President Pro Tempore to appoint members of the Senate to interim committees; authorizing President Pro Tempore to approve claims for reimbursement incurred by members and employees of the Senate during the interim; and providing for cumulative powers.
