HB 1117 – By Rousselot and Pittman of the House and Garrison of the Senate.

An Act relating to schools; amending 70 O.S. 2011, Section 1210.284, which relates to vision screening of students; adding public school nurse to vision screening advisory committee; and providing an effective date.

HB 2170 – By Echols, Fisher, Ritze and Pittman of the House and Dahm of the Senate.

An Act relating to crimes and punishments; amending 21 O.S. 2011, Section 1272, as amended by Section 1, Chapter 259, O.S.L. 2012 (21 O.S. Supp. 2012, Section 1272), which relates to the unlawful carry of certain weapons; deleting certain knife from list of prohibited weapons; and providing an effective date.
