**MESSAGE FROM THE HOUSE**

Advising passage of and transmitting for consideration Engrossed **HBs 1085, 1324, 1383, 1508, 1646** and **2166**.

**HB 1085** – By Grau of the House and Sykes of the Senate.

An Act relating to criminal procedure; amending 22 O.S. 2011, Section 1105.3, which relates to the Pretrial Release Act; modifying pretrial release conditions to include various monitoring and testing methods; and providing an effective date.

**HB 1324** – By McDaniel (Randy) of the House and Sykes of the Senate.

An Act relating to the Oklahoma Police Pension and Retirement System; amending 11 O.S. 2011, Sections 50-114.1, as last amended by Section 10, Chapter 364, O.S.L. 2012 and 50-114.4 (11 O.S. Supp. 2012, Section 50-114.1), which relate to limitation on benefits pursuant to requirements of the Internal Revenue Code; modifying reference to Internal Revenue Code; modifying provisions related to permissive service credit; modifying provisions related to repayments; modifying references for purposes of certain qualified health insurance premiums; and declaring an emergency.

**HB 1383** – By McDaniel (Randy) of the House and Stanislawski of the Senate.

An Act relating to the Oklahoma Law Enforcement Retirement System; amending 47 O.S. 2011, Section 2-305, as amended by Section 2, Chapter 307, O.S.L. 2012 (47 O.S. Supp. 2012, Section 2-305), which relates to retirement benefit computations; modifying retirement benefit computation for certain members; and declaring an emergency.

**HB 1508** – By Peterson, Nelson, Pittman and Cooksey of the House and David of the Senate.

An Act relating to public health and safety; amending 63 O.S. 2011, Section 2-103.1, which relates to the Uniform Controlled Dangerous Substances Act; expanding scope of subpoena powers for the Director of the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control; and providing an effective date.

**HB 1646** – By Jordan of the House and Bingman of the Senate.

An Act relating to corporations; amending 18 O.S. 2011, Section 1027, as amended by Section 1, Chapter 1, O.S.L. 2012 (18 O.S. Supp. 2012, Section 1027), which relates to the Oklahoma General Corporation Act; deleting mandate of dividing board of directors into classes for certain type of corporation; removing exception for certain corporation; deleting resolution process for certain election; and declaring an emergency.

**HB 2166** – By Echols, Nelson and Pittman of the House and Crain of the Senate.

An Act relating to child support; amending 21 O.S. 2011, Section 566.1, which relates to contempt for failure to pay child support; permitting judge to order willfully unemployed obligor to complete certain community service program, if available; and providing an effective date.
