**HB 1233** – By Coody, Virgin and Nollan of the House and Halligan of the Senate.  
[ schools - certification and pay for teachers in certain special education areas -  
effective date –emergency ]

**HB 1243** – By Martin (Steve), Ritze and Bennett of the House and Barrington of the Senate.

An Act relating to crimes and punishments; amending 21 O.S. 2011, Section 1279, which relates to penalties for pointing a firearm; updating description of handgun license; amending 21 O.S. 2011, Section 1290.11, as amended by Section 31, Chapter 259, O.S.L. 2012 (21 O.S. Supp. 2012, Section 1290.11), which relates to the Oklahoma Self-Defense Act; clarifying temporary preclusive period for deferred sentences; and providing an effective date.

**HB 1259** – By Shelton of the House and Coates of the Senate.

An Act relating to children; amending 10 O.S. 2011, Sections 404.2 and 404.3, which relate to Demarion’s Law; updating statutory reference; requiring insurance or self-insurance coverage of child care facilities; removing exceptions to posting notice requirements; specifying alternative compliance requirements; directing Department of Human Services to promulgate rules for alternative compliance; requiring facility post notice of alternative compliance; and providing an effective date.

An Act relating to criminal procedure; amending 22 O.S. 2011, Sections 991a and 991c, which relate to sentencing powers of the court and supervision fees; requiring payment of fee to district attorney; authorizing waiver by district attorney; and prohibiting court from waiving, suspending, deferring or dismissing certain requirement.

**HB 1361** – By Grau, Ritze, Christian, Kern, Biggs, Fisher and Hulbert of the House and Treat of the Senate.

An Act relating to public health and safety; amending 63 O.S. 2011, Section 1-740.2, which relates to notification and consent of a parent prior to performance of abortion; adding certain requirements to parental notice and consent; requiring certain notice to be filed with certain district court; permitting court to require evaluation and counseling session prior to judicial waiver hearing; stating purpose; amending 63 O.S. 2011, Section 1-740.3, which relates to judicial authorization prior to abortion; providing certain factors the court may and may not consider in assessing certain minor; providing for codification; and providing an effective date.

**HB 1462** – By Ownbey and Ritze of the House and Simpson of the Senate.

An Act relating to crimes and punishments; amending 21 O.S. 2011, Sections 1290.14 and 1290.15, as amended by Sections 34 and 35, Chapter 259, O.S.L. 2012 (21 O.S. Supp. 2012, Sections 1290.14 and 1290.15), which relate to the Oklahoma Self-Defense Act; terminating fingerprint submission requirement for certain renewals; providing for ten-year registration certificates; stating fee; allowing firearm training and qualification course providers to determine course fees; and providing an effective date.

**HB 1489** – By Ritze, Murphey, Derby, Bennett, Kern, McCullough and Cockroft of the House and Brecheen of the Senate.

An Act relating to public finance; creating the Modernization of Self-Defense Act Application Process of 2013; amending 62 O.S. 2011, Sections 34.24.1 and 34.25, as amended by Sections 357 and 358, Chapter 304, O.S.L. 2012 (62 O.S. Supp. 2012, Sections 34.24.1 and 34.25), which relate to the Oklahoma State Finance Act; modifying exemption process to include certain license; exempting certain license from convenience fee; providing for noncodification; and providing an effective date.

An Act relating to title insurers; amending 36 O.S. 2011, Section 5001, which relates to issuing title insurance; modifying who is authorized to countersign title insurance policy; defining term; and providing an effective date.

**HB 1792** – By Christian, Turner and Moore of the House and Holt of the Senate.

An Act relating to uninsured motorists; creating the Oklahoma Temporary Motorist Liability Plan; describing coverage provided under the plan; providing time period and circumstances in which coverage will be applicable; creating the Temporary Insurance Premium Pool; limiting coverage if any other coverage is in effect; requiring the Insurance Commissioner to develop forms; providing bid selection process; providing for Plan Administrator; providing cost of temporary insurance; providing for cause of action; authorizing the Department of Public Safety to promulgate rules; amending 47 O.S. 2011, Section 7-606, as amended by Section 4, Chapter 207, O.S.L. 2012 (47 O.S. Supp. 2012, Section 7-606), which relates to penalties for failure to maintain insurance; providing for seizure of license plate, citation and fees; providing for codification; and providing an effective date.

**HB 1838** – By Williams of the House and Johnson (Rob) of the Senate.

An Act relating to criminal procedure; amending 22 O.S. 2011, Section 18, as amended by Section 2, Chapter 183, O.S.L. 2012 (22 O.S. Supp. 2012, Section 18), which relates to the expungement of records; modifying certain expungement category; and providing an effective date.

All monies accruing to the credit of such fund are hereby appropriated and shall be budgeted and expended by the State Department of Health for the purpose of providing grants to the Oklahoma Lupus Foundation for the purpose of lupus awareness, education, outreach, referral, research or treatment in this state. Expenditures from the fund shall be made upon warrants issued by the State Treasurer against claims filed as prescribed by law with the Director of the Office of Management and Enterprise Services for approval and payment.”, and renumbering subsequent section, which amendment was declared adopted.
