Advising passage of and transmitting for consideration Engrossed **HBs 2417, 2422, 2497, 2518, 2586, 2622** and **3290**.

**HB 2417** – By Ritze, Sherrer, Hoskin and Vaughan of the House and David of the Senate.

An Act relating to the state flag; directing that the state flag be folded in a certain manner; providing for codification; and providing an effective date.

**HB 2422** – By Bennett, Walker, Hulbert, Cleveland, Blackwell, Moore, Fisher, Ritze, Reynolds, Kern and Vaughan of the House and Dahm and Boggs of the Senate.

An Act relating to schools; creating the Religious Viewpoints Antidiscrimination Act; requiring school districts to treat student expression in certain manner; stating purpose; requiring school districts to adopt a limited public forum policy; specifying contents of the policy; requiring certain disclaimer to be provided at graduation ceremonies and other events; prohibiting the exclusion of religious expression from the limited public forum; allowing student religious expression in class assignments; specifying standards for judging homework and classroom assignments; allowing students to organize religious groups and activities; specifying treatment of religious groups; allowing school districts to disclaim school sponsorship of student groups; requiring school districts to adopt and implement a limited public forum and voluntary student expression of religious viewpoints policy; specifying that school districts adopting the model policy are compliant with the act; setting forth the Model Religious Viewpoints Antidiscrimination Policy; defining term; providing for student expression of religious viewpoints; providing for student speakers at nongraduation events; requiring a limited public forum; listing events; listing eligible student speakers; providing for notification and selection of student speakers; specifying subject of the speech of the student; requiring a disclaimer; allowing certain students with special positions to be speakers; providing for student speakers at graduation ceremonies; providing for the establishment of a limited public forum at graduation ceremonies; specifying students eligible to speak; providing for topic of speech; allowing certain students with special positions to be speakers; providing for designation of the subject; requiring a written disclaimer; providing for religious expression in class assignments; requiring homework and classroom work to be judged on certain standard; providing for the freedom to organize religious groups and activities; specifying treatment of religious groups; allowing school districts to disclaim sponsorship of groups and events; providing for codification; providing an effective date; and declaring an emergency.

**HB 2497** – By Casey, Kern, Coody, Pittman and Nollan of the House and Stanislawski of the Senate.

An Act relating to schools; directing the State Department of Education to conduct a study of reading instruction and retention of students; stating purpose of the study; allowing the Department to contract with certain entities; specifying information to be gathered for the study; requiring the Department to issue a report by a certain date; specifying the inclusion of certain recommendations; requiring student data to be aggregated; providing for codification; and declaring an emergency.

## **HB 2518** – By Vaughan of the House and Fields of the Senate.

An Act relating to game and fish; amending 29 O.S. 2011, Section 4-114, which relates to lifetime hunting and fishing licenses; and adding residency requirement for a lifetime hunting or fishing license.
