Second Regular Session of the Fifty-fourth Legislature of the State of Oklahoma

Thirty-seventh Legislative Day, Tuesday, April 8, 2014

JOINT SESSION

Major General Deering addressed the Joint Session and conducted the program commemorating the 45th Infantry Division Appreciation Day.

Major General Deering and Governor Mary Fallin presented the Star of Valor Award to Sergeant E.H. Pittman.

Major General Deering introduced Governor Mary Fallin who addressed the Joint Session.

Colonel Wright read a formal Proclamation from Governor Mary Fallin recognizing 45th Infantry Appreciation Day and presented the Proclamation to Major General Deering.

Upon motion of Representative Peterson, the Third Joint Session was ordered dissolved at the hour of 10:35 a.m.
