**HB 3538** – By Martin (Scott) and Sears of the House and Jolley and Justice of the Senate.

An Act relating to the Workers' Compensation Commission; and authorizing expenditure from the Workers' Compensation Fund.

**HB** 3539 – By Martin (Scott) and Sears of the House and Jolley and Justice of the Senate.

An Act relating to the Workers' Compensation Court of Existing Claims; providing for creation of Revolving Fund; and directing deposit of certain fees, penalties and fines.

**HB 3542** – By Martin (Scott) and Sears of the House and Jolley and Justice of the Senate.

An Act relating to statutes and reports; amending 75 O.S. 2011, Sections 13, 14 and 17, which relate to statutes and session laws; and transferring certain duties from the Chief Clerk-Administrator of the House of Representatives to the Secretary of State.
