First Regular Session of the Fifty-fifth Legislature of the State of Oklahoma

Ninth Legislative Day, Thursday, February 12, 2015

The Senate was called to order by Senator David.

MESSAGE FROM THE HOUSE

Advising passage of and transmitting for consideration Engrossed **HBs 1717, 1729, 1902** and **2154**.

HB 1717 – By Cox and Hoskin of the House and Shaw of the Senate.

An Act relating to the Grand River Dam Authority; amending 82 O.S. 2011, Section 862, as amended by Section 1, Chapter 217, O.S.L. 2012 (82 O.S. Supp. 2014, Section 862), which relates to the Grand River Dam Authority; authorizing volunteer reserve officers for certain purpose; allowing certain law enforcement employees to retain certain equipment upon retirement; authorizing the general manager to award certain equipment to the surviving family upon death of certain law enforcement employees under certain conditions; providing for codification; and declaring an emergency.

HB 1729 – By Roberts (Sean) of the House and David of the Senate.

An Act relating to public health and safety; creating Ashlen's Law; amending 63 O.S. 2011, Section 1-301, which relates to definitions; modifying certain definition; providing for noncodification; and providing an effective date.

HB 1902 – By Johnson, O'Donnell and Lockhart of the House and Loveless of the Senate.

An Act relating to motor vehicles; providing civil immunity for removing child from motor vehicle using forcible entry; listing requirements to comply with in order to receive immunity; construing provision; providing for codification; and providing an effective date.

HB 2154 – By Echols, Grau, Montgomery, Casey, Jordan and Cannaday of the House and Crain of the Senate.

An Act relating to public health and safety; creating Katie's Law; amending 63 O.S. 2011, Section 2-101, as last amended by Section 1, Chapter 154, O.S.L. 2014 (63 O.S. Supp. 2014, Section 2-101), which relates to definitions of the Uniform Controlled Dangerous Substances Act; modifying exception to certain definition; defining terms; providing for the establishment of statewide investigational new drug applications for certain clinical trials; authorizing physicians to serve as principal investigators for clinical trials under certain circumstances; providing for subinvestigators; directing investigators and subinvestigators to adhere to certain rules and regulations; providing guidelines for establishing statewide investigational new drug applications; providing exemptions from criminal or civil penalties; providing for codification; providing for noncodification; and providing an effective date.
