First Regular Session of the Fifty-fifth Legislature of the State of Oklahoma

Twenty-fifth Legislative Day, Thursday, March 12, 2015

Senator Jolley moved to amend **SB 298**, Page 7, Line 18, by inserting after the semicolon “;” the word “and”; and, Page 7, Lines 19 through 22, by deleting paragraph 2 and renumbering the subsequent paragraph, which amendment was declared adopted.

Senator Quinn moved to amend **SB 298**, Page 3, Line 14, by deleting all language after the word “after” and before the period “.” and inserting “January 1, 2016”, which amendment was declared adopted.

Senator Jolley moved to amend **SB 298**, Page 7, Line 8 ½ , by inserting a new subsection F to read as follows:

”F. This act requires the complete and proper disclosure, transparency and accountability relating to any method of payment for life insurance policies, annuities and retained assets regulated by the Insurance Department for those currently in force and those issued and delivered on or after January 1, 2016. This act shall not restrict the state or its agent from assisting the insurer in locating beneficiaries or persons otherwise entitled to payment of claim proceeds for policies issued and delivered before January 1, 2016, as provided in the Uniform Unclaimed Property Act.”, and by re-lettering subsequent subsections, which amendment failed of adoption upon roll call as follows:
