Forty-first Legislative Day, Tuesday, April 14, 2015

President Lamb recognized Colonel Louis Wilham, Oklahoma National Guard, to introduce Adjutant General, Major General Robbie Asher.

Major General Asher addressed the Joint Session and conducted the program commemorating the 45th Infantry Division Appreciation Day.

Major General Asher introduced Governor Mary Fallin who addressed the Joint Session.

Major General Asher recognized Brigadier General (Retired) Harry W. Barnes and his accomplishments.

Colonel Wilham read a formal Proclamation from Governor Mary Fallin recognizing 45th Infantry Appreciation Day and presented the Proclamation to Major General Asher.

Upon motion of Representative Ortega, the Fourth Joint Session was ordered dissolved at the hour of 10:20 a.m.
