First Regular Session of the Fifty-fifth Legislature of the State of Oklahoma

Fifty-fifth Legislative Day, Monday, May 11, 2015

The Senate was called to order by Senator Brooks.

FIRST READING

The following were introduced and read the first time:

SB 839 – By Bingman of the Senate and Hickman of the House.

An Act relating to public finance; creating the Oklahoma Museum of Popular Culture under the Oklahoma Historical Society; authorizing the Oklahoma Historical Society to do certain construction, maintenance, repair, and operation; authorizing the Oklahoma Capitol Improvement Authority to issue obligations to provide funding for construction of the Oklahoma Museum of Popular Culture for the Oklahoma Historical Society; providing for debt retirement payments; directing how title is to be held and when it is to be transferred; authorizing capitalization of certain interest; stating legislative intent; authorizing payment of certain costs; providing methods for issuance of obligations; authorizing hiring certain professionals for certain purpose; providing for sale of obligations by certain methods; limiting maturity of obligations; providing for utilization of certain interest earnings; providing tax exemption; providing for investment of certain monies; requiring compliance with certain statutory provisions; providing for codification; and providing an effective date.

SCR 26 – By Fry of the Senate and Calvey of the House.

A Concurrent Resolution recalling from the Office of the Governor Enrolled Senate Bill No. 41, passed by the 1st Session of the 55th Oklahoma Legislature.

MESSAGES FROM THE GOVERNOR

The veto message reads as follows:

Enrolled Senate Bill No. 549:

This is to advise you that on this date, pursuant to the authority vested in me by Section 11 of Article VI of the Oklahoma Constitution to approve or object to legislation presented to me, I have VETOED Senate Bill 549.

Senate Bill 549 (Bill) dramatically alters how future elected State officers are to be paid. It decouples State officers' salaries from judicial salaries, and instead, codifies a specific and fixed annual salary for each officer, including the Governor, the Lieutenant Governor, the Attorney General, the State Superintendent of Public Instruction, the Corporation Commissioners, the State Treasurer, the State Auditor and Inspector, the State Insurance Commissioner, and the Commissioner of Labor (collectively referred to as "State Officers").

There are two significant deficiencies that compel me to veto this Bill. First, recent compensation reform initiatives have discarded the practice of codifying State employee salaries for good reason: fixing salary in statute tends to calcify salaries without regard to such pertinent considerations as inflation; the current fiscal health of the State; and most importantly, each particular employee's performance.

That is why neutral third-party compensation boards determine the salaries of officials in the other two co-equal branches of Oklahoma government, the Judiciary and the Legislature. These boards are comprised of representatives from a wide swath of our State's citizenry—including labor and civic organizations, communications media and retail business, agriculture, nonstate-supported educational institutions, and religious organizations. As such, the boards emphasize the fact that it is the people of this great State who are the true bosses of the leaders they elect.

It would be better policy to create a new and distinct compensation board for State Officers in the Oklahoma Statutes. In the meantime, however, I cannot approve this Bill. To do so would strip State Officers' compensation decisions from being made at least by a neutral and representative board, that being the Board on Judicial Compensation, which currently sets the salaries to which State Officers' salaries are tied.

MESSAGES FROM THE GOVERNOR

Advising her approval May 11, 2015, of Enrolled **SBs 134, 136, 322, 326, 340, 439, 455, 474 and 715.**

The veto message reads as follows:

ENROLLED SENATE BILL NO. 41:

This is to advise you that on this date, pursuant to the authority vested in me by Section 11 of Article VI of the Oklahoma Constitution to approve or object to legislation presented to me, I have VETOED Senate Bill 41.

Senate Bill 41 is a law that seeks to clarify the Business Owner's Rights Act, and specifically, whether a "property owner, tenant, employer, place of worship or business entity may prohibit any person from carrying a concealed or unconcealed firearm on the property" if that property is "designated by a city, town, county, or **state** governmental authority as a park, recreational area, or fairgrounds."

Although I strongly defend Oklahomans' right to bear arms, and understand that the Business Owner's Rights Act may need to be strengthened by the Legislature at some time in the future, this Act is currently the subject of pending litigation in District Court in Cleveland County. Our Constitution clearly prohibits the Legislature from passing legislation that would "take away [a] cause of action, or destroy any existing defense" to a suit that has already commenced.

As a result, because Senate Bill 41 could substantively influence or even determine the outcome of pending litigation, any approval of it at this time is likely unconstitutional. It is for this reason that I hereby veto Senate Bill 41.
