## Second Regular Session of the Fifty-fifth Legislature of the State of Oklahoma

**Fifteenth Legislative Day, Wednesday, February 24, 2016**

Advising passage of and transmitting for consideration Engrossed **HBs 2357, 2410, 2413, 2547, 2615, 2649, 2761, 2785, 2922 and 3024.**

**HB 2357** – By Watson of the House and Marlatt of the Senate.

An Act relating to storage tanks; amending 17 O.S. 2011, Sections 302 and 303, which relate to the Oklahoma Storage Tank Regulation Act; deleting references to hazardous substances in legislative findings; deleting definition of hazardous substance; modifying certain definitions; and providing an effective date.

**HB 2410** – By Faught of the House and Dahm of the Senate.

An Act relating to sunset; amending 59 O.S. 2011, Section 161.4, as amended by Section 1, Chapter 70, O.S.L. 2012 (59 O.S. Supp. 2015, Section 161.4), which relates to the Board of Chiropractic Examiners; re-creating the Board; and modifying termination date.

**HB 2413** – By Faught of the House and Dahm of the Senate.

An Act relating to sunset; amending 63 O.S. 2011, Section 91, as last amended by Section 76, Chapter 15, O.S.L. 2013 (63 O.S. Supp. 2015, Section 91), which relates to the State Anatomical Board; re-creating the Board; and modifying termination date.

**HB 2547** – By Mulready of the House and David of the Senate.

An Act relating to the Oklahoma Telemedicine Act; repealing 36 O.S. 2011, Section 6804, which relates to informed consent; and providing an effective date.

**HB 2615** – By Thomsen of the House and Halligan of the Senate.

An Act relating to schools; providing definitions; prohibiting persons from giving money or a thing of value to a student-athlete or family member for certain purposes; prohibiting persons from entering into or soliciting a transaction with a student-athlete that would result in certain sanctions; providing certain exceptions; establishing penalty; requiring high schools to advise certain students of the provisions of the law and to provide certain information; granting a right of action by a postsecondary institution against certain persons engaging in activity concerning student-athletes; providing for recovery of damages; specifying damages; allowing additional right of action and remedies; providing for codification; and providing an effective date.

**HB 2649** – By Thomsen of the House and Fields of the Senate.

An Act relating to schools; amending 70 O.S. 2011, Section 1-111, as last amended by Section 1, Chapter 203, O.S.L. 2013 (70 O.S. Supp. 2015, Section 1-111), which relates to the length of the school day; adding an exception to the number of school days allowed in a twenty-four-hour period; providing an effective date; and declaring an emergency.

**HB 2761** – By Kirby of the House and Brown of the Senate.

An Act relating to insurance; amending 36 O.S. 2011, Section 309.4, as amended by Section 1, Chapter 298, O.S.L. 2015 (36 O.S. Supp. 2015, Section 309.4), which relates to examination reports; providing that certain waivers of confidentiality shall not occur under certain circumstances; amending 36 O.S. 2011, Section 607.1, as last amended by Section 1, Chapter 296, O.S.L. 2015 (36 O.S. Supp. 2015, Section 607.1), which relates to entities considered insurers; exempting certain entities from filing certain actuarial opinions; amending 36 O.S. 2011, Section 1452, as last amended by Section 2, Chapter 145, O.S.L. 2014 (36 O.S. Supp. 2015, Section 1452), which relates to the Third-party Administrator Act; limiting certain annual reports that shall be reviewed by a certified public accountant; requiring certain application for waiver under certain circumstances; amending 36 O.S. 2011, Section 1510, as amended by Section 1, Chapter 50, O.S.L. 2014 (36 O.S. Supp. 2015, Section 1510), which relates to valuation; eliminating certain exemption for certain domestic companies; amending 36 O.S. 2011, Section 1654, as amended by Section 9, Chapter 269, O.S.L. 2013 (36 O.S. Supp. 2015, Section 1654), which relates to registration of insurers; requiring annual registration; requiring certain annual enterprise risk report be filed by certain date; amending 36 O.S. 2011, Section 4101.1, which relates to group life insurance policies and annuities; increasing age cap for certain dependents; amending 36 O.S. 2011, Section 6060.4, which relates to child immunization coverage; modifying which health benefit plans are exempted from certain requirements; amending 36 O.S. 2011, Sections 6121 and 6124, which relate to prepaid funeral services; authorizing the Insurance Commissioner to deny permit to certain persons; prohibiting new permit after prior refusal to issue permit; amending 36 O.S. 2011, Sections 6220, as amended by Section 5, Chapter 297, O.S.L. 2015 and Section 7, Chapter 297, O.S.L. 2015 (36 O.S. Supp. 2015, Section 6220 and 6223), which relate to the Insurance Adjusters Licensing Act; modifying causes to deny, suspend or revoke license; modifying content requirements for certain disclosure document; amending 36 O.S. 2011, Section 6470.2, as last amended by Section 14, Chapter 298, O.S.L. 2015 and Section 6470.3, as amended by Section 15, Chapter 298, O.S.L. 2015 (36 O.S. Supp. 2015, Sections 6470.2 and 6470.3), which relate to the Oklahoma Captive Insurance Company Act; modifying punctuation; modifying insurable risks; amending 36 O.S. 2011, Section 6670, as last amended by Section 22, Chapter 15, O.S.L. 2013 (36 O.S. Supp. 2015, Section 6670), which relates to insurance coverage of portable electronics; updating citation; and providing an effective date.

**HB 2785** – By Hardin of the House and Simpson of the Senate.

An Act relating to disability insurance; amending 74 O.S. 2011, Section 1335, which relates to participation in the Disability Insurance Program; updating reference; authorizing cities to participate in the Program; providing for starting date for participation; providing for all employees of participating city to be covered; requiring city to provide certain contributions; directing the Oklahoma Employees Insurance and Benefits Board to determine contribution amount; and providing an effective date.

**HB 2922** – By Kirby of the House and Sparks of the Senate.

An Act relating to bail bonds; amending 59 O.S. 2011, Sections 1301, as amended by Section 1, Chapter 53, O.S.L. 2014, 1302, 1306, as last amended by Section 1, Chapter 110, O.S.L. 2015, Section 3, Chapter 53, O.S.L. 2014, as amended by Section 2, Chapter 110, O.S.L. 2015, and as renumbered by Section 13, Chapter 110, O.S.L. 2015, 1310, as last amended by Section 4, Chapter 110, O.S.L. 2015, 1311.3, as last amended by Section 5, Chapter 110, O.S.L. 2015, Section 13, Chapter 373, O.S.L. 2014, 1314, as last amended by Section 6, Chapter 110, O.S.L. 2015, 1316, as last amended by Section 8, Chapter 110, O.S.L. 2015, 1317, as last amended by Section 9, Chapter 110, O.S.L. 2015 and 1328, as amended by Section 24, Chapter 407, O.S.L. 2013 (59 O.S. Supp. 2015, Sections 1301, 1306, 1306.1, 1310, 1311.3, 1311.4, 1314, 1316, 1317 and 1328), which relate to the licensing and regulation of bail bondsmen; updating statutory citations; modifying certain definitions; clarifying certain investigation requirement; adding requirement for professional bail bondsman license; clarifying circumstances that allow for a license to be denied, suspended or revoked; modifying exception to certain prohibited act; modifying requirements that allow a bondsman to receive assistance from another bondsman; modifying references to specified bondsmen; providing time limitation for the retention of certain records; directing bondsmen to provide certain documentation for appearance bonds; deleting certain requirement for issuing receipts; clarifying procedures relating to appointment forms; requiring bondsmen to possess bail bondsman license when apprehending or surrendering defendants; and providing an effective date.

**HB 3024** – By Jordan of the House and Holt of the Senate.

An Act relating to civil procedure; creating the Catfishing Liability Act of 2016; defining terms; providing cause of action for Internet catfishing; providing for liability; providing for injunctive relief; providing for actual and punitive damages; providing exception from liability; making remedies cumulative; providing for codification; and providing an effective date.
