HB 1538 – By Thomsen and McDaniel (Randy) of the House and Barrington of the Senate.

An Act relating to the Oklahoma Law Enforcement Retirement System; amending 47 O.S. 2011, Section 2-305, as last amended by Section 1, Chapter 318, O.S.L. 2013 (47 O.S. Supp. 2015, Section 2-305), which relates to benefit computations; providing for computation of benefits based upon disability; providing for computation of benefits for persons retired prior to designated date; providing for computation of benefits for persons who retire on or after designated date; making appropriation from the Special Cash Fund; prescribing amount and purpose; providing concurrent funding pursuant to the Oklahoma Pension Legislation Actuarial Analysis Act; and declaring an emergency.

Supp. 2015, Section 1371), which relates to the Oklahoma State Employees Benefits Act; authorizing the Oklahoma Employees Insurance and Benefits Board to offer alternative insurance plan to retirees; and providing an effective date.

An Act relating to administrative rules; amending 75 O.S. 2011, Sections 250.3, as amended by Section 2, Chapter 357, O.S.L. 2013, 308, as amended by Section 4, Chapter 357, O.S.L. 2013 and 308.1, as amended by Section 5, Chapter 357, O.S.L. 2013 (75 O.S. Supp. 2015, Sections 250.3, 308 and 308.1), which relate to the Administrative Procedures Act; modifying definitions; providing for approval or disapproval of rule by the Governor; modifying legislative approval and disapproval of rules; requiring approval of certain rules; modifying final adoption of rule; repealing Section 6, Chapter 357, O.S.L. 2013 (75 O.S. Supp. 2015, Section 308.3), which relates to the omnibus joint resolution; providing for codification; providing for noncodification; and providing an effective date.

HB 2275 – By Denney of the House and Jolley of the Senate.

An Act relating to DNA testing; requiring submission of DNA samples from persons arrested for felony crimes; providing procedures for testing DNA samples; stating persons responsible for taking DNA samples; providing collectors of DNA samples immunity from civil liability; stating time limitation for mailing DNA samples; requiring destruction of DNA samples unless certain conditions met; providing for the automatic expungement of DNA samples under certain circumstances; directing the Oklahoma State Bureau of Investigation to promulgate certain rules; amending 20 O.S. 2011, Section 1313.2, which relates to court fund fees; adding definition; directing certain persons to pay DNA fee; amending 74 O.S. 2011, Section 150.27a, which relates to the OSBI Combined DNA Index System (CODIS) Database; modifying purpose of database to include DNA samples from certain persons; providing for codification; and providing an effective date.

Supp. 2015, Section 1135.2), which relates to recognition of service specialty license plates; modifying eligibility standard for the Disabled Veterans License Plate; creating the United States Coast Guard Auxiliary license plate; providing for eligibility; limiting to certain type of vehicle; providing for design of license plate; creating the United States Public Health Service License Plate; providing for eligibility; limiting to certain type of vehicle; requiring plate to contain certain seal or logo; creating the United States Public Health Service Retired Service License Plate; providing for eligibility; limiting to certain type of vehicle; requiring plate to contain certain seal or logo; amending 47 O.S. 2011, Section 1135.3, as last amended by Section 1, Chapter 378, O.S.L. 2015 (47 O.S. Supp. 2015, Section 1135.3), which relates to demonstration of support or affiliation specialty license plates; limiting Don't Tread on Me License Plate to certain type of vehicle; providing for Don't Tread on Me Motorcycle License Plate; transferring authority for certain Jenks Trojans License Plate to another section of law; amending 47 O.S. 2011, Section 1135.5, as last amended by

Section 2, Chapter 378, O.S.L. 2015 (47 O.S. Supp. 2015, Section 1135.5), which relates to demonstration of support and financial assistance specialty license plates; creating the Disabled American Veterans License Plate; creating the Prisoner of War and Missing in Action License Plate; creating the John Rex Charter Elementary School License Plate; re-creating the Jenks Trojans License Plate; creating the Bixby Spartans License Plate; creating the Rocky Mountain Elk Foundation License Plate; creating the Western Heights Public Schools License Plate; creating the Former Oklahoma House Member License Plate; establishing plates as financial assistance license plates; providing for design of license plates; allowing and providing limitations on personalization of license plates; requiring certain portion of fees be deposited in certain funds; authorizing certain licensing agreements; authorizing and limiting certain payments; requiring incorporation of certain numbering system; requiring creation and maintenance of certain list; amending 47 O.S. 2011, Section 1127, as amended by Section 1, Chapter 413, O.S.L. 2014 (47 O.S. Supp. 2015, Section 1127), which relates to motor vehicle registration fees for armed forces members; clarifying references; making terms gender neutral; providing reduced cost registration for Purple Heart recipients and inactive duty members of the Oklahoma National Guard; creating the Prisoner of War and Missing in Action License Plate Revolving Fund; placing fund with the Military Department; considering certain funds appropriated; exempting Fund from certain budgetary requirements; requiring certain budgetary procedures; providing for codification; and providing an effective date.

HB 2555 – By Wright and Biggs of the House and Sykes of the Senate.

An Act relating to motor vehicles; amending 47 O.S. 2011, Sections 11-902, as last amended by Section 3, Chapter 393, O.S.L. 2013 and 11-904, as amended by Section 1, Chapter 157, O.S.L. 2012 (47 O.S. Supp. 2015, Sections 11-902 and 11-904), which relate to penalties for driving or operating a vehicle while under the influence; modifying conditions related to subsequent and multiple convictions for driving under the influence; modifying penalty for causing great bodily injury while driving or operating a vehicle while under the influence; and providing an effective date.

HB 2571 – By Russ of the House and Brooks of the Senate.

The statement must not contain any other information that would indicate, imply, or identify the class, type, description, or name of the products purchased. Any information that would indicate, imply, or identify the class, type, description, or name of the products purchased is considered strictly confidential.

B. The statement may be provided by first class mail, email, or other electronic communication.”, and by renumbering subsequent sections, which amendment was declared adopted.
