Fifty-third Legislative Day, Wednesday, May 4, 2016

The Senate was called to order by Senator Dahm.

FIRST READING

The following were introduced and read the first time:

SB 1578 – By Jolley and Treat of the Senate and Sears and Casey of the House.

An Act relating to income tax credit; amending 68 O.S. 2011, Section 2357.46, which relates to income tax credit for expenditures incurred by certain contractors; limiting time period during which certain credit shall be allowed; and providing an effective date.

SB 1579 – By Jolley and Treat of the Senate and Sears and Casey of the House.

An Act relating to tax administration; directing Oklahoma Tax Commission to enhance agency enforcement efforts related to sales, use and income tax; specifying types of enforcement efforts; amending 68 O.S. 2011, Section 1002, which relates to gross production tax procedures; directing Oklahoma Tax Commission to enhance agency enforcement efforts related to gross production tax; specifying types of enforcement efforts; providing for noncodification; providing an effective date; and declaring an emergency.

SB 1580 – By Jolley and Treat of the Senate and Sears and Casey of the House.

An Act relating to income tax credit; amending Section 1, Chapter 421, O.S.L. 2014 (68 O.S. Supp. 2015, Section 2357.403), which relates to income tax credit for investment in qualified affordable housing projects; providing exception to total amount of credits allocated annually; modifying total amount of credits allocated for specified time periods; and providing an effective date.

SB 1581 – By Jolley and Treat of the Senate and Casey and Sears of the House.

An Act relating to income tax credit; amending 68 O.S. 2011, Section 2357.22, as last amended by Section 12, Chapter 328, O.S.L. 2014 (68 O.S. Supp. 2015, Section 2357.22), which relates to income tax credits for investment in clean-burning motor vehicle fuel property; providing certain exceptions; updating reference; limiting total amount of certain credit which may be claimed during specified time period; providing for annual adjustment of total amount of credits subject to certain limit based on specified calculation and prescribing applicable methodology; providing exception to certain limit under specified circumstances; reducing amount of credit allowed for certain time period; and providing an effective date.

SB 1582 – By Jolley and Treat of the Senate and Sears and Casey of the House.

An Act relating to income tax credits; amending 68 O.S. 2011, Section 2357.4, as amended by Section 1, Chapter 336, O.S.L. 2015 (68 O.S. Supp. 2015, Section 2357.4), which relates to tax credits for investment in depreciable property or net increase in employees; limiting total amount of certain credit which may be claimed during specified time period; providing for annual adjustment of total amount of credits subject to certain limit based on specified calculation and prescribing applicable methodology; providing exception to certain limit under specified circumstances; and providing an effective date.
