Ninth Legislative Day, Thursday, February 16, 2017

MESSAGES FROM THE HOUSE

Advising passage of and transmitting for consideration Engrossed **HBs 1394** and **2332**.

HB 1394 – By Downing of the House and McCortney of the Senate.

An Act relating to criminal procedure; amending 22 O.S. 2011, Section 1601, as amended by Section 1, Chapter 309, O.S.L. 2013 (22 O.S. Supp. 2016, Section 1601), which relates to the Domestic Violence Fatality Review Board; eliminating sunset termination date; and providing an effective date.

HB 2332 – By Coody and Moore of the House and Quinn of the Senate.

An Act relating to motor vehicles; amending 47 O.S. 2011, Sections 7-600.2, as amended by Section 1, Chapter 88, O.S.L. 2016 and 7-602, as amended by Section 1, Chapter 146, O.S.L. 2015 and Section 1, Chapter 365, O.S.L. 2016 (47 O.S. Supp. 2016, Sections 7-600.2, 7-602 and 7-606.1), which relate to compulsory liability insurance; transferring the online compulsory insurance verification system from the Department of Public Safety to the Oklahoma Insurance Department; authorizing the Insurance Department to promulgate rules; authorizing district attorneys to access the verification system; modifying information to be included in the security verification system;

authorizing the Insurance Commissioner to initiate administrative proceedings against noncomplying insurance companies; modifying acceptable verification in certain circumstances; expanding who may submit such verification; authorizing use of electronic mail in certain circumstances at no cost to the person registering the vehicle; updating references; and providing an effective date.

The above-numbered measures were read the first time.

Advising the signing of and transmitting for signature Enrolled **HCR 1004**.
