An Act relating to pharmacies; amending 59 O.S. 2011, Section 353.24, as last amended by Section 5, Chapter 285, O.S.L. 2016 (59 O.S. Supp. 2016, Section 353.24), which relates to the Oklahoma Pharmacy Act; clarifying terms; amending Section 1, Chapter 263, O.S.L. 2014, as amended by Section 7, Chapter 285, O.S.L. 2016 (59 O.S. Supp. 2016, Section 357), which relates to pharmacy benefit plans; modifying definitions; amending Section 6, Chapter 154, O.S.L. 2014 (63 O.S.
