**Second Regular Session of the Fifty-sixth Legislature**

**of the State of Oklahoma**

**Thirty-sixth Legislative Day, Friday, April 6, 2018**

The Senate was called to order by Senator Sykes.

## **REPORT OF ENGROSSED AND ENROLLED MEASURES**

**HBs 2553** and **3536** were each correctly engrossed and, together with engrossed **SAs**, properly signed and ordered returned to the Honorable House.

**SBs 937** and **939** were each correctly enrolled and after fourth reading, properly signed and ordered transmitted to the Honorable House for signature of the Speaker.

**SR 25** was correctly enrolled, properly signed and ordered transmitted to the Secretary of State.

Senator Treat moved that the Senate recess to the Call of the Chair, which motion was declared adopted.

### **GENERAL ORDER**

### **THIRD READING**

**HB 3375** was read for the third time at length.

The bill passed.

Senators Rader and Simpson desired to vote Aye on the emergency.

On the question of passage of the emergency, the vote resulted as follows: Aye: 31; Nay: 14; Excused: 3.

The emergency failed.
