## First Regular Session of the Fifty-seventh Legislature of the State of Oklahoma

Twelfth Legislative Day, Wednesday, February 20, 2019

**MESSAGE FROM THE HOUSE**

Advising passage of and transmitting for consideration Engrossed **HBs 1036, 1216, 1296, 1297, 1853, 1911, 2119, 2368, 2670** and **2676**.

**HB 1036** – By Walke and Lawson of the House and Rosino of the Senate.

An Act relating to children; amending 10A O.S. 2011, Sections 1-4-709, as amended by Section 1, Chapter 242, O.S.L. 2016 and 1-4-906 (10A O.S. Supp. 2018, Section 1-4-709), which relate to the Oklahoma Children's Code; prohibiting guardianship if prospective guardian is the child's parent and parental rights have been terminated; excluding parent's right to apply for guardianship of child after termination of parental rights; barring Department of Human Services from recommending certain people seek guardianship of child in custody; and providing an effective date.

**HB 1216** – By Sanders of the House and Murdock of the Senate.

[ roads, bridges and ferries - requiring Department of Transportation to incur signage costs - eliminating qualifications for highway and bridge dedications - effective date ]

**HB 1296** – By Miller and Luttrell of the House and Rosino of the Senate.

An Act relating to state government; amending 74 O.S. 2011, Section 18c, as last amended by Section 1, Chapter 31, O.S.L. 2016 (74 O.S. Supp. 2018, Section 18c), which relates to employment of attorneys by state officials or entities; eliminating termination date for employment of attorneys by the Oklahoma Department of Veterans Affairs; and providing an effective date.

**HB 1297** – By Miller and Luttrell of the House and Rosino of the Senate.

An Act relating to veteran guardianships; creating the Veterans Volunteer Guardianship Act; requiring certain existing veteran guardianships comply with certain guardianship laws; directing district court to review certain existing guardianships; authorizing guardianship of veteran appointments; specifying type of guardian; providing guardianship petition and order content requirements; making certain guardianship duties, requirements and protections applicable to guardianships established under this act; requiring guardian maintain regular contact with certain entities and individuals; providing ward and guardian eligibility requirements; construing provisions of this act; requiring bond; authorizing waiver or reduction of bond under certain circumstances; directing bond to be provided or reimbursed by the Oklahoma Department of Veterans Affairs under certain conditions; requiring certain federal fiduciary accountings be included in certain annual accountings to the district court; authorizing a guardian to work in consultation with certain federally appointed institutional fiduciary; amending 30 O.S. 2011, Sections 3-104 and 3-110, as amended by Section 2, Chapter 320, O.S.L. 2016 (30 O.S. Supp. 2018, Section 3-110), which relate to adult guardianships; expanding list of priorities for court

selection of guardians; requiring certain notice to the Secretary of the United States Department of Veterans Affairs; amending 30 O.S. 2011, Section 4-201, which relates to guardian's bond; updating reference; amending 30 O.S. 2011, Section 4-303, which relates to settlement and allowance accounts; updating reference; amending 56 O.S. 2011, Section 192, which relates to exemption from costs in guardianship cases; exempting guardianships of persons receiving veteran disability compensation or pension from certain guardianship costs; repealing 72 O.S. 2011, Sections 126.1, 126.2, 126.3, 126.4, 126.5, 126.6, 126.7, 126.8, 126.9, 126.10, 126.11, 126.12, 126.13, 126.14, 126.15, 126.16, 126.17, 126.19, 126.20, 126.22 and 126.23, which relate to the Revised Uniform Veterans' Guardianship Act; providing for recodification; providing for codification; and providing an effective date.

**HB 1853** – By Fetgatter of the House and Bice of the Senate.

An Act relating to public finance; amending 62 O.S. 2011, Section 842, which relates to the Oklahoma Local Development and Enterprise Zone Incentive Leverage Act; modifying dates for purposes of creation of certain districts and authorization related to payments or tax credits; and providing an effective date.

**HB 1911** – By Boles and McEntire of the House and Kidd of the Senate.

An Act relating to public health and safety; amending 63 O.S. 2011, Section 330.52, as amended by Section 1, Chapter 295, O.S.L. 2018 (63 O.S. Supp. 2018, Section 330.52), which relates to the Oklahoma State Board of Examiners for Long-Term Care Administrators; modifying requirements for members; and providing an effective date.

**HB 2119** – By Ortega of the House and Howard of the Senate.

An Act relating to cities and towns; amending 11 O.S. 2011, Section 15-103, as amended by Section 1, Chapter 41, O.S.L. 2016 (11 O.S. Supp. 2018, Section 15-103), which relates to initiative and referendum petitions; specifying certain qualifying election; defining term; and providing an effective date.

**HB 2368** – By Kannady of the House and Thompson of the Senate.

An Act relating to opioids; creating the Oklahoma Commission on Opioid Abuse; providing for membership; stating purpose of the Commission; requiring certain report; allowing for travel reimbursement; requiring compliance with the Oklahoma Open Meeting Act; providing for staffing; providing for codification; providing an effective date; and declaring an emergency.

**HB 2670** – By Wallace of the House and Thompson of the Senate.

An Act relating to public finance; creating the Pay for Success Act; allowing for specific citation; stating legislative intent; defining certain phrases; authorizing certain contracts under certain conditions; prohibiting certain contracts under certain conditions; requiring certain contract elements; requiring certain annual reports; requiring provision of

certain reports to certain individuals by certain date; placing requirements and limitations on certain payments; authorizing payments from certain fund sources; creating the Pay for Success Innovation Fund; designating the fund to the Office of Management and Enterprise Services; describing the nature and limitations of the fund; authorizing budgeting and expenditure of funds for certain purposes under certain conditions; providing for the return to agencies of unpaid amounts under certain conditions; authorizing the entrance into memorandums of understanding; authorizing the promulgation of rules; providing for codification; and providing an effective date.

**HB 2676** – By Wallace, Crosswhite Hader, Phillips, Tadlock, Hilbert, Kerbs, Newton, Lawson, Russ, West (Josh), Caldwell (Trey), Fetgatter, Pfeiffer, Sanders, Luttrell and Ortega of the House and Thompson of the Senate.

An Act relating to transportation funding; making an appropriation to the County Improvements for Roads and Bridges Fund; stating amount; identifying source; stating purpose; providing for noncodification; providing an effective date; and declaring an emergency.
